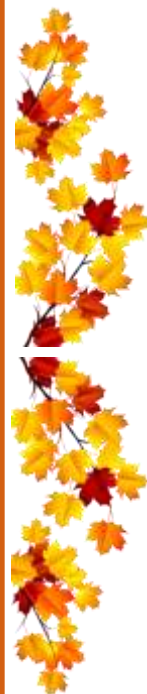
## REMINDER: 2024 DUES NOW PAYABLE

### LAST RANSON CRUISE-IN

Well, it's the 29th of Sept., so the Friday night cruise-ins at the Roy Rogers in Ranson, WV (by the Home Depot) have officially concluded. I didn't make it to the Friday evening event all summer but made it a point to attend the last before the host club, Country Roads Car Club, wrapped things up for the season. Attendance was light but it was cool to see a big block 68 Coronet 500 convertible that I had never seen before. The car was sold new in Martinsburg and has been in this area its



entire life. Others in attendance included several Chevelles, an Olds Vista Cruiser, a 64 Plymouth Fury, a Trans Am, a Charger, a few Camaros, a Nash, a couple street rods, and an assortment of vintage Ford and Chevy pickups.

### FALL CARLISLE SEPT 28-30

For my buddies and I, attending Fall Carlisle on Thursday has become a sort of tradition. Thursday morning, before the first car crosses the auction block, is the best time to see all the cars in the auction, so that's where we started. There was quite the variety of cars. A sleek early 70's Ferrari 365 GTC was the only exotic we spotted at Carlisle. The unusual Rambler American sedan delivery was one of three built. The mid 60's GMC was my favorite of the trucks in the auction.



The two tone Crestliner was a flashy post sedan with a vinyl top that Ford

introduced to compete with GM's new 2-door pillarless hardtops. It was a desperate attempt to make the post sedan more attractive to buyers until Ford could introduce their own 2-door hardtop. That happened in 51 which eliminated the need for the Crestliner.



Among the cars in the car corral pavilion, I was most drawn to the green 383 70 Coronet 500 convertible. But I'm not a fan of green cars, or the unusual grille design of the 70 Coronet, so I wasn't tempted by the \$70,000 price tag on the rare car (924 Coronet 500 convertibles were built for the 1970 model year). The 36 Ford Phaeton reminded me of the one from the old 60's TV show, "The Ghost and Mrs. Muir" that was driven by the actor Charles Nelson Riley. The car corral at Carlisle has shrunk over the years as the auction has grown. Fewer cars meant the car corral no longer extended to the top of the hill. A bright red 40 Ford was the sole car visible up on the hill saving us the climb to the top *[next page]*.

door hardtop had 12k miles and a price of \$32,900. Everyone I spoke to felt the pretty red 59 Impala was overpriced at \$130,000. A sign on the window revealed it was "showing 29K miles." The purple 70 Road Runner was nicely equipped with a 383, 4-speed and "air grabber" hood. A 51 Mercury coupe

was parked in front of a 51 Mercury convertible. Both awaited new owners. The 71 Olds Cutlass S coupe looked like it was priced fairly at \$21,500.

**AACA FALL NAT'L - HERSHEY**

Friday October 6th was the annual AACA car show at Hershey. Rain cleared out early allowing for a comfortable car show day with temps in the upper 60's to mid-70's. The skies were mostly overcast, keeping the sun from baking the show goers and softening the harsh shadows between bright sun and shade. I managed to take over 700 pictures but will try to keep the photos I submit to a minimum.



Cars in the DPC (Driver Participation Class) are "drivers" and are not expected to be perfectly restored or preserved examples. Above, the rare '64 Studebaker Lark Daytona convertible (only about 700 convertibles were made for 64, before production moved to Canada and the product line was trimmed down to just post sedans and wagons).



Muscle cars [bottom left] were well represented at Fall Hershey. We have a Plymouth Superbird, a Ford Torino Cobra, and a 69 Pontiac Trans Am from the Muscle classes. The '55-57 T-birds, Corvettes, Mustangs, and '57 Chevys each have their own class, since they appear in large numbers.



The '80s and '90s cars now qualify as antiques. Here's a trio of '80s Monte Carlo SS's.



Among the trucks were a Mack cement mixer, a milk truck, and a Corvair "Rampside" pickup. In the sports car class was a '74 Saab Sonnet and a '63 Shelby Cobra. [Editor: some of us saw the Cobra close up on our Fun Run to Vintage Motorcar in Inwood].

## PROPOSED AMENDMENTS TO THE BY-LAWS OF SHENANDOAH REGION, AACA

The Executive Board voted 10/19/2023 to recommend adopting the proposed changes below. The proposal will be voted upon by the Members present at the Nov. 2 Membership meeting. The By-laws Committee drafting the amendments was comprised of: Dan Rowzie, Kevin Malony, Jeff Smulovitz, and Linda Comontofski.

[Existing text in black italics. Proposed changes in red font. Purpose of the proposed change in blue font.]

### ARTICLE 2: Officers Section 2: Past President

*"The outgoing Regional President, if not re-elected and unless disqualified, shall serve ~~for 1 year in the following capacity~~ as President Emeritus during the incoming President's term. If the outgoing President is re-elected, the previous President Emeritus shall continue to serve. (1) ~~He/She shall~~ The President Emeritus: (1) Shall have voting privilege on the Executive Board. (2) May be called upon by the Regional President when needed, i.e., conducting meetings in the absence of the President and Vice President."*

[Purpose: to clarify when an outgoing President is re-elected to a consecutive additional term, the previous President continues into the next term, not limited to 1 year]

### ARTICLE 3: Election of Officers Section 2: Ballots

*"Before the November membership meeting a ballot ~~will be mailed~~ shall be prepared and distributed to each Member in good standing either via email or by inclusion in the November newsletter by the Newsletter Editor (see Article 4, Section 9). More ballots would be included if additional members are in the household. Each member shall mark his/her ballot and return it to the Secretary at or before the membership meeting in November. Members may send their marked ballot by email or submit their paper copy."*

[Purpose: to allow for voting via email, and to codify having the ballot in the newsletter, which has been done for the last several years]

### ARTICLE 3: Election of Officers Section 3: Voting at November Membership Meeting

*"In case a member forgets to bring his ballot, no additional ballots will be distributed at the meeting".*  
*"If a member forgets to bring his/her ballot, or was unable to print their ballot received via email per Article 3, Section 2, a small number of extra paper ballots shall be available for their use, so long as the Secretary has not previously received said member's ballot".*

[Purpose: to allow for members who receive ballots via email but do not have a way to print their ballot to vote. It should also not be necessary to suppress ballots for those members who were forgetful.]

### ARTICLE 4: Duties of Officers Section 1: President

*"The Regional President shall preside and preserve order at all meetings of the Region, shall appoint committees, and may call a special meeting at any time. In case of inclement weather, or other changes in the availability of a meeting venue, he/she may also cancel or reschedule a scheduled meeting".*

[Purpose: there was no provision in the past when the meeting had to be canceled because of snow, COVID, etc. and the Executive Board had to scramble to get an emergency vote to cancel]

### ARTICLE 4: Duties of Officers Section 9: Newsletter Editor

*"He/she will compile the news for the newsletter and ~~mail~~ said letter to each paid member before the monthly membership meeting publish said letter in an electronic format, and in a paper format if paper copies are needed. Before the monthly membership meeting, he/she will distribute the newsletter as follows: via email to paid members having email addresses or via U.S. mail to those paid members without email addresses".*

[Purpose: to codify the use and distribution of electronic newsletters already in practice.]

**ARTICLE 5: Meetings – Time and Place Section 3:**

~~“A special meeting may be called by the Regional President at any time. The Secretary shall notify all members at least five days prior to this meeting.”~~ “The Regional President may cancel or call a new meeting, as outlined in Article 4, Section 1. The Secretary shall notify all members of the meeting change via email, and the telephone committee (as defined in Article 9 Section 3) shall contact those members who do not have email addresses. Cancellation notices shall go out as soon as the information is known. Notices of a special meeting shall go out at least five days prior to the special meeting”.

[Purpose: to be consistent with Article 4, Section 1 above, and to allow for email notification and help by the telephone committee.]

**ARTICLE 7: Membership Section 1:**

~~“Prospective applicants and their sponsor must be present at a membership meeting or other club activity prior to the application being voted upon by the Executive Board”.~~

[Purpose: to be consistent with AACA policy, as AACA application sponsors are optional, and to allow potential Region members to apply during our Region car shows, tours, etc.]

**ARTICLE 7: Membership Section 2:**

~~“Applications for membership must be in writing, filed with the secretary, and accompanied with the dues for the current year along with the applicant’s National AACA membership card or a copy of same other verification of their current AACA membership.”~~


[Purpose: for clarification - obtaining a copy of the AACA membership card is not necessary, as verification of AACA membership status is easily available on the AACA web site]

**ARTICLE 7: Membership Section 4:**

~~“All applications for membership received and accepted after November 1st shall include membership for the succeeding year”.~~ on or after October 1st shall include membership for the succeeding year if accepted”.

[Purpose: to be consistent with AACA policy. For example, AACA applications during the AACA National Meet in Hershey, which always occurs in October, are effective for the succeeding year.]

The Dodge Daytona reminded me of an identical one a buddy of mine had back in the mid-80's. The red stripe really helped show off the body lines of the black '68 Chevelle SS.

The '69 Mach I was another car decorated for Halloween. The '50 Ford pickup with the flathead V8 under the hood appeared to have been beautifully and correctly restored, but the color choice wasn't correct for a '50 Ford truck. Last, a blue '60 Impala .

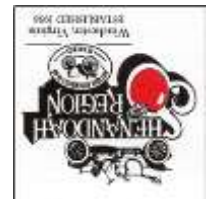
